More than one position could be hired from this posting. If a subsequent vacancy of the same position type becomes available within a reasonable time of the original announcement, the U.S. Probation & Pretrial Services Office may elect to select a candidate from the original qualified applicant pool.

Position Overview

The U.S. Probation & Pretrial Services Office for the District of Maine includes locations in both Portland and Bangor. This position is located in the Bangor office. Bangor is located in central Maine, 130 miles north of Portland, and is the gateway to Downeast Maine, the Acadia Region (including Bar Harbor and Acadia National Park), Baxter State Park, the Penobscot Bay Region, and Nova Scotia, Canada. Bangor is the state's 3rd largest city, with a population of approximately 32,000, and has a rich history dating back to the 1600's. The Bangor area offers many recreational activities including access to dozens of lakes and streams with superior fishing; the Gulf of Maine's coastline and many islands, including lobstering and fishing communities; hiking, biking and camping; and a wide range of winter sports including skiing/snowboarding, snowmobiling, ice fishing, and snowshoeing.

By statute, probation and pretrial services officers serve in a judiciary law enforcement position and assist in the administration of justice. The officer promotes community safety, gathers information, supervises offenders/defendants, interacts with collateral agencies, prepares

reports, conducts investigations, and presents recommendations to the court. Officer specialists manage a caseload that includes a significant proportion of offenders/defendants of a specialized type, and serve as local experts on cases of this type. The Special Offender Specialist performs duties that involve both general pretrial services or probation cases and specialized types of offenders/defendants.

The Special Offender Specialist is responsible for sharing the program oversight and development of the district's sex offender program, including the investigation and supervision of sex offenders with high-risk issues; intensive supervision is often required for the high-risk offenders in this category. The incumbent serves as the in-house authority on matters relating to sex offenders and provides officer training in this area. Probation and pretrial services officer specialists must carry at least a 50 percent caseload, spending at least 50 percent of their time working with defendants and/or offenders. Officer specialists may guide the work of probation/pretrial services officer assistants and other staff.

Duties and Responsibilities

- ➤ Performs investigative and supervision responsibilities for defendants/offenders in both general and specialized cases. Conducts investigations and prepare reports for the court with recommendations, which require interviewing offenders/defendants and their families, as well as collecting background data from various sources. An integral part of this process is interpretation and application of policies and procedures, statutes, Federal Rules of Criminal Procedures, and may include U.S. Sentencing Guidelines, Monographs, and relevant case law.
- Enforces court-ordered supervision components, and implements individual-focused supervision treatment strategies for optimum results. Assesses offenders' level of risk and develops a blend of strategies for controlling or correcting risk management to reduce violations and/or recidivism. Supervises a general caseload and a specialized caseload of high risk sex offenders.
- Consults with line officer staff concerning sex offender cases and sex offender treatment services. Coordinates district-wide sex offender treatment services contracting and placement of offenders in treatment services. Coordinates monitoring and evaluating effectiveness of sex offender treatment services. Serves as the liaison to the Bureau of Prisons and community corrections centers for offenders with sex offenses.
- Works collaboratively with treatment services specialist to coordinate treatment services contracting and monitoring activities, including review and oversight of vendor invoicing.
- ➤ Works collaboratively and effectively with other special offender specialists to insure proper supervision of sex offenders pursuant to national and local policies.
- ➤ Maintains records and coordinates sex offender polygraphs conducted regularly by contract vendors.
- Acts as a resource for management in the formulation, implementation, and assessment of office practices, policies, and procedures in the area of specialty. Develops and prepares written procedures to ensure overall understanding and consistency in the supervision of sex offenders within the district.

- ➤ Participates in the administrative planning of specialized caseloads. Provides advice, program vision and direction to management on modifications to the program with the intent of improving services to the Court.
- Anticipates, originates, recommends, develops, implements, and manages policies and procedures relating to the area of specialization for the district. Regularly evaluates the local policy and procedures to ensure compliance with applicable portions of the Guide to Judiciary Policy.
- Tracks legal developments and advises management and staff of any changes in case law.
- ➤ Guides, advises, and makes recommendations to other officers, the court and other individuals regarding treatment issues, monitoring, and course of action regarding their designated area of specialty.
- ➤ Conducts training for staff as needed in regards to area of specialty. Provides training to identify trends, tools, and techniques, and recent case law as applicable to area of specialty. Trains officers on identification and treatment of defendants/offenders with high risk issues.
- Serves as a resource and expert to the court, line officers, and staff in high-risk and/or specialized cases. Recommends policies and procedures for the district as to specialty cases, including training practices, managing and assigning caseloads, establishing backups and coverage, alert response protocol, identifying appropriate defendant/offenders, etc.
- Participates in on-going training and educational opportunities to further develop and/or enhance techniques and skills relating to investigation and supervision practices of offenders/defendants in area of specialization. Provides management and staff with ongoing updates related to changes with this offender/defendant population.
- Tracks developments in the law and updates staff and the court. Enforces courtordered supervision components and implements supervision strategies. Maintains
 personal contact with defendants and offenders through office and community contacts
 and by telephone. Investigates employment, sources of income, lifestyle, and associates
 to assess risk and compliance. Addresses substance abuse, mental health, domestic
 violence, and similar problems and implements the necessary treatment or violation
 proceedings, through assessment, monitoring, and counseling.
- ➤ Reviews and resolves disputed issues involving offenders/defendants and present unresolved issues to the court for resolution.
- Communicates with other organizations and persons (such as the U.S. Parole Commission, Bureau of Prisons, law enforcement, treatment agencies, and attorneys) concerning offenders'/defendants' behavior and conditions of supervision. Identifies and investigates violations and implements appropriate alternatives and sanctions. Reports violations of the conditions of supervision to the appropriate authorities. Prepares written reports of violation matters, and makes recommendations for disposition. Testifies at court or parole hearings. Conducts Parole Commission preliminary interviews.
- Responds to judicial officer's request for information and advice. Testifies in court as to the basis for factual findings and (if warranted) guideline applications. Serves as a resource to the court. Maintains detailed written records of case activity. May conduct surveillance and/or search and seizure at the discretion of the court.

- Performs administrative duties regarding area of specialty and guides the work of staff providing administrative and technical assistance to officers.
 Performs other duties as assigned.

Qualifications

Minimum Qualifications: Completion of a bachelor's degree from an accredited college or university in a field of academic study such as criminal justice, criminology, psychology, sociology, human relations, business or public administration which provides evidence of capacity to understand and apply the legal requirements and human relations skills involved in the position, is required for all probation and pretrial services officer positions.

First-time appointees to positions covered under Federal law enforcement officer retirement provisions must not have reached their 37th birthday at the time of appointment. Applicants 37 or over who have previous law enforcement officer experience under the Civil Service Retirement System or the Federal Employees' Retirement System and who have either a subsequent break in service or intervening service in a non-law enforcement officer position may have their previous law enforcement experience subtracted from their age to determine whether they meet the maximum age requirement.

Preferred Qualifications: Three years of specialized experience, which includes progressively responsible experience gained after completion of a bachelor's degree in such fields as probation, pretrial services, parole, corrections, criminal investigations, or work in substance abuse, mental health, or sex offender treatment. Knowledge and experience in computer monitoring methods is preferred. The candidate must demonstrate the ability to implement, maintain, and develop policy, and to work collaboratively with others in the implementation of a district-wide program.

To qualify at the CPS Classification Level 27, an applicant must have two years of specialized experience, including at least one year equivalent to work at the CL 25 level or have completed a master's degree in a field of study closely related to the position, or a Juris Doctor (JD) degree.

To qualify at the CPS Classification Level 28, an applicant must have two years of specialized experience, including at least one year equivalent to work at the CL 27 level.

To qualify for CPS Classification Level 29, an applicant must have three years of specialized experience, including at least one year as a CL 28 Probation/Pretrial Services Officer in the U.S. Courts.

Specialized Experience

Specialized experience is progressively responsible experience, gained after completion of a bachelor's degree, in such fields as probation, pretrial services, parole, corrections, criminal investigations or work in substance/addiction, mental health, or sex offender treatment. The successful candidate must have a proven track record of technical excellence in investigations or supervision, as well as excellent interpersonal skills and excellent verbal and written communication skills. He/She must have the ability to manage multiple tasks, prioritize work effectively, and meet deadlines.

Physical Requirements: The duties of probation officers require the investigation and

management of convicted criminal offenders who present physical danger to officers and to the public. In the supervision, treatment and control of the offenders, these duties require moderate to arduous physical exercise, including prolonged periods of walking and standing and use of self-defense tactics. On a daily basis, these officers face unusual mental and physical stress because they are subject to danger and possible harm during frequent, direct contact with individuals who are convicted of committing federal offenses. Because officers must effectively deal with physical attacks and are subject to moderate to arduous physical exertion, applicants must be physically capable. Any candidate the court is appointing to an officer position will be subject to a pre-employment medical examination. The applicant must be determined medically qualified prior to commencement of duties. The medical requirements for probation officers and probation officer assistants are available for public review at www.uscourts.gov.

Background Investigation, Drug Screening and Medical Standards: As conditions of employment, incumbent will be subject to ongoing random drug screening, updated background investigations every five years and, as deemed necessary by management for reasonable cause, may be subject to subsequent fitness-for-duty evaluations.

Benefits

Benefits include participation in the retirement system, health and life insurance programs, holiday and leave accrual, and periodic salary increases. Optional benefits include tax free medical and dependent care accounts and dental and vision insurance. The court is not authorized to reimburse candidates for travel or moving expenses. Applicants must be U.S. Citizens or eligible to work in the United States. Employees are required to have EFT for payroll deposit.
